_____ I understand that this procedure requires individual synthetic eyelash extensions to be adhered to my own natural eyelashes.

_____ I understand that it is my responsibility to keep my eyes completely closed and to be as still as possible for the entire procedure, until my eyelash technician addresses me to open my eyes.

_____ I understand that some risk of this procedure may be, but not limited to *Eye-Redness and/or Irritation*. The fumes from the adhesive may cause my eyes to tear up if I do open my eyes.

_____ I agree to disclose any and all allergies that I may have to *Latex, Surgical Tapes, Cyanocrylate, Vaseline, etc.*

_____ I understand that I am required to follow the Eyelash Extension Care Sheet, that will be provided to me at the end of my initial session, in order to maintain the life and integrity of Beautif-EYE's lash extensions.

_____ I am of sound mind and fully capable of executing this waiver for myself.

_____ I give Beautif-EYE, LLC. and Beautif-EYE Employee's to take photos of my lashes and use photos for social media and advertising purposes: YES _____ NO _____

_____ I understand and am fully aware eyelash fills should be done every 2-3 weeks and lashes must be at a minimum of 50% retention to be considered a classic Lash Fill. If retention is Less Than 50% additional time will be required at appointments along with additional fees.

_____ I understand purchasing Borboleta Lash Shampoo is highly recommended and using any other cleaners/product to cleanse the lashes will result in premature lash loss and void Beautif-EYE's quality guarantee.

_____ Beautif-EYE, LLC. and Beautif-EYE employee's will NOT be held liable for any damage to lashes, lash area, and or skin allergies.

_____ Beautif-EYE, LLC. and Beautif-EYE employee's will NOT be held liable for any damage that you may cause by trying to remove the lash extensions on your own. All Lash Removals need to be a scheduled visit with your licensed lash artist at either Beautif-EYE location.

_____ Any Eyelash Extension Redo's due to issues with excessive lash loss or pain due to twisted or tugging of lashes, must be fixed with-in 5 days from previous appointment. Lash Redo appointments are only 30 minutes. Any additional time OR after 5 days from original service date will be given a 15% discount. No exceptions will be made.

_____ Do Not perm or tint your eyelashes before or after lash extension application. Do Not use an eyelash curler. Do Not rub your eyes or lashes when washing your face. Do Not pull your lashes. Do not use mascara. Do Not cut the extensions.

Eyelash Extensions Aftercare Requirements:

- ❖ Do NOT get eyelashes wet and keep lash area moisture free for a full 24hrs after all eyelash services. This includes, but not limited to; Showering, Swimming, Physical Workouts, Sweating, Saunas, and Hot tubs.
- ❖ Do NOT pick or pull on your natural or synthetic lashes.
- ❖ Gently cleanse lashes daily using Borboleta Beauty Lash Cleanser.
- ❖ Brush your Eyelashes Daily with recommended lash brush. This encourages any lashes in the Telogen stage to come out naturally while keeping them looking nice and not tangled.
- ❖ Do NOT sleep on your face. If you are a side sleeper you will experience more lash loss on that side. Using a Silk Pillowcase can keep lashes on longer since Cotton Pillowcases cause friction that can cause breakage to hair, including lash hairs.
- ❖ Avoid any and all Oily Products on your face. This includes make-ups, eye-creams, eye serums, lotions, etc. Anything Oily disintegrates lash adhesive which will result in VOIDING Beautif-EYE's 5-day care policy.

STRICT AND ENFORCED 24 HOUR CANCELLATION POLICY!

We understand that sometimes schedule adjustments are necessary; therefore, we respectfully request at least 24-hour notice for all cancellations/reschedule request. We will send a confirmation text reminder 24hrs in advance so if you do need to cancel your appointment for any reason you are able to respond to that message or call the studio directly.

- ❖ Cancellation “Day of” Appointment or less than 24-hour notice will be charged 50% of service.
- ❖ Clients more than 15 minutes late to their scheduled appointments will result in forfeiting their appointment and will be charged 50% of their scheduled service.
- ❖ “NO SHOWS” will be charged 100% of the reserved service amount.
- ❖ Appointments made “DAY OF” service and end up needing to cancel, the client then must cancel within 4-hours of the appointment time or will result in a charge equal to 50% of the reserved service amount.
- ❖ If multiple Spa Services are scheduled, then Beautif-EYE’s cancellation policy applies to each individual service. Also, a credit card “HOLD” transaction may be made on your credit card to reserve your appointment.
